

# Domestic Violence and Abuse: A Referral Pathway for Victims in Portsmouth



## Definition of domestic violence and abuse

Any incident or pattern of incidents of controlling, coercive or threatening behaviour, violence or abuse between those aged 16 or over who are or have been intimate partners or family members regardless of gender or sexuality. This can encompass, but is not limited to, the following types of abuse: psychological; physical; sexual; financial; and emotional.

## What is a risk assessment (DASH)?

Risk assessment is a crucial part of helping to deal with DVA. Levels of risks need to be identified and established to ensure the most appropriate course of action, and also to ensure the victim's safety. In Portsmouth we recommend that everyone uses the Safe Lives DASH risk assessment. Which identifies cases that need to be referred to MARAC.

## What is MARAC?

In a single meeting, a domestic abuse Multi Agency Risk Assessment Conference combines up-to-date risk information with a comprehensive assessment of a victim's needs and links those directly to the provision of appropriate services for all those involved in a domestic abuse case victim, children and perpetrator.

## What support is available? (see over for referral routes and details)

**PIP** - Provides IDVA support to victims assessed at high risk of domestic abuse and who are considered at MARAC. Scoring 14+ on the DASH risk assessment or professional judgement indicates a victim is at high risk and provides group provision for victims

**SDA** - provides the refuge in Portsmouth, supports victims assessed as medium risk of domestic abuse (scoring 8-13 on the DASH assessment)

**Victim Care** - Provides support to victims assessed as standard risk (1-7 on DASH risk assessment)

**Up2U** - Provides support to those who use unhealthy behaviours in their relationship. To meet the threshold an individual must acknowledge they use unhealthy behaviours and want to change.

## Group provision:

**Who's in Charge:** a 9 week course for parents whose child (10+) is acting abusively to them or beyond their control

**Rockpool:** a 12 week course for male and female victims of DVA who are no longer in an abusive relationship

**Freedom:** an 11 week course for female victims of DVA who are still in an abusive relationship

**NVR:** 11 week course for parents whose child's (5-18) making unreasonable demands leading to battles or aggression

# Domestic abuse disclosure - what should I do?



Do you have any immediate concerns for your client's welfare or safety?

Yes

In an emergency call 999 and ensure the client's safety.

Are there children or adults at risk involved?

Yes

Refer to your agency's procedures for children and adults at risk and make a referral to Children's or Adult' Services and contact Children or Adult's MASH as appropriate

AND



Complete DASH risk assessment with the victim and/or consider professional judgement



## In all cases talk to your client about:

- Safety planning
- What your agency should do to help them and keep them safe and which other agencies should be contacted
- If they want information to take away or what, if any, support they require
- Consent to refer to SDAS or Victim Care. If high risk consent is not needed however client should be informed.



### HIGH RISK

14 ticks or more on DASH assessment or evidence professional judgement. Refer to MARAC using referral form (email [portsmouth.mash.admin@hampshire.pnn.police.uk](mailto:portsmouth.mash.admin@hampshire.pnn.police.uk) and refer to PIP ([IDVA@secure.portsmouthcc.gov.uk](mailto:IDVA@secure.portsmouthcc.gov.uk) or 02392 688472) for DVA support

### MEDIUM RISK

8-13 ticks on DASH assessment or professional judgement Refer to SDA (023 9206 5494 or [portsmouth.referral@sdas.cjsm.net](mailto:portsmouth.referral@sdas.cjsm.net) providing client has consented for specialist domestic abuse support

### STANDARD RISK

1-7 ticks on DASH risk assessment or professional judgement Assessing agency to provide support to victim or make a referral to Victim Care (0808 178 1641) or email [hiow.referrals@victimsupport.cjsm.net](mailto:hiow.referrals@victimsupport.cjsm.net) Providing client has consented
